Program Details

<i>Who is eligible to apply?</i>	Any licensed agency or organization that has a reputable program for children or youth.
<i>What form does the grant take?</i>	<p>Grant recipients will receive gift certificates to Gethsemane Gardens in Andersonville to purchase plants, soil and/or soil amendments and mulch. Purchases can be charged to the RPGG account.</p> <p>Grant amounts will depend on the size and needs of the garden and what funds are available.</p> <p>Grants are accepted and reviewed at any time in the year and are distributed to eligible programs on a first-come, first-serve basis.</p>
<i>What projects are eligible?</i>	<p>Any project that can demonstrate that it:</p> <ul style="list-style-type: none">• Is sponsored by an agency or organization with experience in providing excellent programming for children or youth• Provides children and youth with hands-on gardening experience and education• Is located in Rogers Park, specifically: south of Evanston, east of Ridge, north of Devon,• Is capable of completion by the end of the 2016 gardening season (for exceptions, see below)• Will be undertaken by people with the capacity to complete and maintain it – e.g., weed and water• Has a realistic budget

<i>What is the grant process?</i>	After grants are received: <ul style="list-style-type: none">• An RPGG representative will contact you for a site visit• The Organizing Committee of the RPGG will make a decision• You will be notified by email of the decision and the gift certificates can be picked up or will be mailed to you.
